6. The intending bidders must be registered on e-tendering portal [www.tenderwizard.com/DMRC](http://www.tenderwizard.com/DMRC). Those who are not registered on the e-tendering portal shall be required to get registered beforehand. If needed they can be imparted training on ‘online tendering process’. After registration the tenderer will get user ID and password. On login, tenderer can participate in tendering process and can witness various activities of the process.

7. The authorized signatory of intending bidder as per Power of Attorney (POA) or its representative must have valid class-III digital signature. The tender document can only be obtained/downloaded and tender submissions can be uploaded using class-III digital signature through user ID & password.
8. Tender submission will be made online after uploading the mandatory scanned documents towards cost of tender documents and tender security such as Demand Draft or Pay Order or Banker's Cheque from a Scheduled commercial bank based in India and other documents as stated in the tender document.
9. All bidders are hereby cautioned that tenders containing any material deviation or reservations as described in Clause 30. of "Instructions to bidders" and/or deviations without quoting the cost of withdrawal shall be considered as non-responsive and is liable to be rejected.
10. Tenders shall be valid for a period of **180 days** (both days inclusive i.e. the date of submission of tenders and the last date of period of validity of the tender) from the date of submission of Tenders and shall be accompanied with a tender security of the requisite amount and acceptable form as per Clause C21 of ITB.
11. DMRC reserves the right to accept or reject any or all proposals without assigning reasons. No bidders shall have any cause of action or claim against the DMRC for rejection of his proposal.
