1.2 Minimum Eligibility Criteria -

- 1.2.1 <u>Works Experience</u>- The tenderer will be qualified only if they have completed work(s) similar works during last seven years ending 31.03.2015 as under:
 - (a) Three similar completed works costing not less than Rs.71.7 Lakh; or
 - (b) Two similar completed works costing not less than Rs.89.6 Lakh; or
 - (c) One similar completed work costing not less than Rs. 143.5 Lakh.

Notes:

- The tenderer shall submit details of work executed by them in the Performa of Annexure-2 of FOT for the works to be considered for qualification of work experience criteria. Documentary proof such as completion certificates from client clearly indicating the nature/scope of work, actual completion cost and actual date of completion for such work should be submitted. The offers submitted without this documentary proof shall not be evaluated.
- For completed works, value of work done shall be updated to 31.03.2015 price level assuming 5% inflation for Indian Rupees every year.
- Construction of building will be considered as 'Similar work'

1.3 POINTS TO BE NOTED

- 1.3.1 Works envisaged under this contract are required to be executed in all respects within the period of completion mentioned above.
- 1.3.2 The mere fact that the tenderer satisfies all the "Tender Qualification Criteria" shall not imply that his tender shall automatically be accepted. The same should contain all technical details as required for the consideration of tender. A bidder can be awarded only.

Those who are not registered on the e-tendering portal shall be required to get registered beforehand and after registration at e-portal tenderer have to intimate CE/W about their registration, so that their names can be included in the list of pre-qualified agencies.
