

NOTICE INVITING TENDER

1.1 GENERAL

1.1.1 Name of Work:

Delhi Metro Rail Corporation (DMRC) Ltd. invites open tenders (online) from the tenderers who is qualifying the eligibility criteria for execution of work “ **Provision of protective barricading & allied works at open land near Sarai Kale Khan**”. The detailed Site information is provided in Clause 2.0.

1.1.3 ELIGIBILITY REQUIREMENTS

1.1.3.1 Work Experience:

Experience of having satisfactorily completed similar works during last 3 years period ending last day of the month previous to the one in which the tenders are invited should be either of the following:

- (i) Three similar completed works each costing not less than the amount equal to Rs. 25,36,526 (40% of the estimated cost)

or

- (ii) Two similar completed works each costing not less than the amount equal to Rs. 31,70,658 (50% of the estimated cost)

or

- (iii) One similar completed work costing not less than the amount equal to Rs. 50,73,053 (80% of the estimated cost)

Experience detail duly certified shall be submitted in Form T-II.

1.1.3.2 Financial Standing (Annual Turnover) :

The average annual turnover (from construction works) of applicant during each of last three audited financial years should not be less than Rs. 50.70 lakh.

Tenderer shall submit last three years audited financial statement duly attested and certified by Chartered Accountant to work out net worth and turnover. The net worth must be > 9.26 Lakh. Profit before Tax should be Positive in at least 2(two) year, out of the last three audited financial years.

The tenderer should have minimum three years experience of civil works in any Central Govt./state Govt./PSU's/DMRC or any private Limited company of repute, (relevant documentary proof has to be submitted).

Definition of similar work: The work analogous to that defined in clause 2.2.

1.1.3.3 Bid Capacity

The intending tenderer will be disqualified if their available bid capacity is less than approximate cost of work as per NIT. The available bid capacity should be equal to or more than the estimated value of work.

1.1.3.4 The Available bid capacity will be calculated as under:-

$$\text{Available Bid Capacity} = 2 (A \times N) - B$$

Where,

A = Max. Value of works executed in any one year during the last 3 years

N = Time of completion in years.

B = Value of existing commitments for ongoing construction works during the period of 'N' years.

1.1.3.5 The financial statement of year having maximum turnover within previous three financial years has to be uploaded in Form T-V duly certified by Chartered Accountant with his stamp, signature and membership number. The annual turnover from construction works only shall be indicated & certified by CA.

1.1.3.6 Value of existing commitments for ongoing construction works during the period of 'N' years has to be submitted by the tenderers in Form T-V. These data shall be certified by the Chartered Accountant with his stamp, signature and membership number.

Tenderer shall submit last three years audited financial statement duly attested and certified by chartered Accountant to work out net worth and turnover. The net worth must be positive.

Applicant must not have been black listed or deregistered by any Govt. or Public sector undertaking during last 5 years the contractor has to submit an undertaking on Rs. 10 stamp paper duly attested by notary.

1.1.3.7 The bidders may note that this tender is based on one packet system and scrutiny of documents along with tender submission will be done after opening of bid. If at any stage, any bidder found non- responsiveness with the criteria mentioned in this document, bidder will be disqualified and their bid will not be evaluated further.

1.2 POINTS TO BE NOTED

1.2.1 Works envisaged under this contract are required to be completed in all respects within the period of completion mentioned above.

1.2.2 The Tender documents consist of:

- Notice Inviting Tender (NIT)
- Instructions to Tenderers (ITT)
- Special Conditions of Contract
- Bill of Quantities

Following document even though not attached as a part of tender document but will form integral part of the same. The work is to be carried out in accordance with GCC shall be strictly followed. These documents can be collected separately from DMRC o/o CPM3, if required. The tenderers while quoting their rates must carefully consider all the requirements of these documents:

- **General conditions of contract.**
- **Safety, Health & Environment.**

These documents will form integral part of Contract Agreement also.

- 1.3 The tenderers may obtain further information in respect of these tender documents from the office of Project Manager-3C, DMRC, Delhi Metro Rail Corporation, Tuglak Crescent Park, Tuglak Road, Near Race Course Metro Station, New Delhi-110011.
- 1.4 All Tenderers are hereby cautioned that tenders containing any material deviation or reservations as described in Clause 20.0 of "Instructions to Tenderers" and/or minor deviation without quoting the cost of withdrawal shall be considered as non-responsive and shall be liable to be rejected.
- 1.5 The intending bidders must be registered on e-tendering portal <https://eprocure.gov.in/eprocure/app>. Those who are not registered on the e-tendering portal shall be required to get registered beforehand. If needed they can be imparted training on 'online tendering process'. After registration the tenderer will get user id and password. On login tenderer can participate in tendering process and can witness various activities of the process.
- 1.6 The authorized signatory of intending bidder, as per Power of Attorney (POA), must have valid class-III digital signature. The tender document can only be downloaded or uploaded using Class-III digital signature of the authorized signatory.
- 1.7 Tender submissions will be made online after uploading the mandatory scanned documents towards cost of tender documents such as Demand Draft or Banker's Cheque issued from a Scheduled commercial bank based in India and towards Tender Security such as Bank Guarantee or Demand Draft or Banker's Cheque from a Scheduled commercial bank based in India and other documents as stated in the tender document.
- 1.8 Late tenders (received after date and time of submission of bid) including tender security/EMD shall not be accepted under any circumstances.
- 1.9 DMRC reserves the right to accept or reject any or all proposals without DMRC for rejection of his proposal.
- 1.10 Bidders shall note that the maximum file size that can be uploaded is 5 MB. All the uploaded files in tender submission should be named properly and arrange systematically.
