

## Invitation for Prequalification (IFP)

March 2017

India

(PQ AE-01)

1. The Delhi Metro Rail Corp. Ltd. (herein after referred to as “the Employer”) intends to prequalify contractors and/or firms for “**Design, Detail Engineering, Supply, Installation, Testing and Commissioning of 110 KV RECEIVING CUM-25 KV AC TRACTION CUM- 33 KV AUXILIARY MAIN SUB STATIONS at two locations -DN NAGAR & CHARKOP DEPOT (Line 2A) and Samarth Nagar –Vikhroli(E) (Line 6) of Mumbai Metro Rail Project -(Contract package: AE-01)”**”.
2. The value of works is approximately ₹ 120 Crores (One Hundred Twenty Crores). The work is likely to be awarded in two lots, DMRC reserves the right to select the number of lots.
3. It is expected that Invitation for bids will be made by 2017-18.
4. The intending applicants must be registered on e-tendering portal [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app) Those who are not registered on the e-tendering portal shall be required to get registered beforehand. If needed they can be imparted training on ‘online tendering process’. After registration, the applicant will get user id and password. On login, applicants can participate in prequalification application process and can witness various activities of the process.
5. A complete set of the Prequalification Document may be purchased by interested Applicant(s) on [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app) upon payment of a **non-refundable fee of ₹ 21,000 (Rupees Twenty One Thousand Only) through Bank Draft / Bankers Cheque issued in favour of “Delhi Metro Rail Corporation Limited”, payable at “New Delhi”**

Alternatively, applicant can also freely download the PQ Document through online mode on e-tendering website [www.delhimetrorail.com](http://www.delhimetrorail.com). The applicants, who have downloaded the PQ document shall be solely responsible for checking the website [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app) for any addendum/amendment issued subsequently to the PQ Document and take into consideration the same while preparing and submitting the Application for Pre-Qualification. The requisite fee shall be submitted at the time of submission of application.

6. Prequalification application submissions shall be done online on <https://eprocure.gov.in/eprocure/app> after uploading the mandatory scanned documents towards cost of prequalification application documents such as Demand Draft or Pay Order or Banker’s Cheque from a Scheduled commercial bank based in India and other documents as stated in the

prequalification application document.

7. Applications for prequalification should be submitted online on e-tendering website [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app) not later than **01.05.2017** and be clearly marked “ **Application to Prequalify for Design, Detail Engineering, Supply, Installation, Testing and Commissioning of 110 KV RECEIVING CUM-25 KV AC TRACTION CUM- 33 KV AUXILIARY MAIN SUB STATIONS at two locations -DN NAGAR & CHARKOP DEPOT (Line 2A) and Samarth Nagar –Vikhroli(E) (Line 6) of Mumbai Metro Rail Project - (Contract package: AE-01)**”.
8. Submission of prequalification applications shall be closed on e-tendering website of DMRC at the date & time of submission prescribed in ITA after which no application shall be accepted. It shall be the responsibility of the applicant to ensure that his prequalification application is submitted online on e-tendering website <https://eprocure.gov.in/eprocure/app> before the deadline of submission. DMRC will not be responsible for non-receipt of prequalification documents due to any delay and/or loss etc.
9. Prequalification applications shall be valid for a period of **180 days** (both days inclusive i.e. the date of submission of prequalification applications and the last date of period of validity of the prequalification application) from the date of submission of prequalification applications
