

EXPRESSION OF INTEREST

Delhi Metro has been instrumental in ushering in a new era in the sphere of mass urban transportation in India. The swanky and modern Metro system introduced comfortable, air conditioned and eco-friendly services for the first time in India and completely revolutionized the mass transportation scenario not only in the National Capital Region but the entire country.

Presently, the Delhi Metro network consists of 327 Km having 236 stations with an average per day ridership of 30 lakhs (approx). The network has now crossed the boundaries of Delhi to reach NOIDA and Ghaziabad in Uttar Pradesh, Gurugram, Faridabad, Balabharh and Bahadurgarh in Haryana. The Airport Express link between Indira Gandhi International Airport and New Delhi has now propelled Delhi to the league of global cities which have high speed rail connectivity between the city and the airport.

DMRC has been licensing bare space to Scheduled Commercial Banks and non-bank entities incorporated in India under Companies Act 1956 for the installation of ATMs/Cash Recyclers. With a view to provide banking facilities to metro commuters, it is proposed to lease out 4 sqm space for the installation and operation of ATMs at each of 293 locations of 221 metro stations of DMRC network. Expression of Interest in this regard is accordingly invited from scheduled commercial banks and other non-bank entities for the installation and operation of ATMs/Cash Recyclers at various offered locations.
